




Dear Mr. Park:

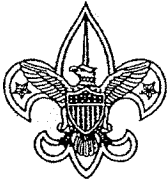

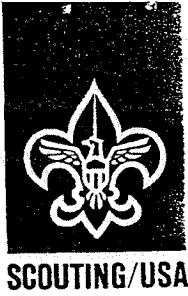

This letter is in regard to all the correspondence and phone calls we have had on a Mr. Elmer Myers in our Council. You may recall there was some question about disqualifying Elmer from registration in the Boy Scouts of America. During my last conversation with you around November 18th, I think you indicated you would like to have more information regarding his stability in the community.

You may recall I indicated the Scouting Coordinator and other leaders are aware of the situation and are careful to not place Elmer in a position of being with any Scouts alone. In addition, one of my staff members sat down with Mr. Myers and received the following information:

1. He has been married to the same wife since 1977, and this is his third marriage.
2. He has six children, all boys ... ranging from age seven to twenty. In addition to this, he has one daughter living with an ex-wife.
3. He has lived in Denver since 1973.
4. He is employed at APG Security as a security guard for the past twenty-seven months. He has had various security positions ... past five years he has had police clearance and a Colorado State license as a security guard.
5. In addition, he has done warehouse work with Karman Western Wear from 1975 - 1979.



Thank You for your "certified" letter of September 10, 1986 concerning your Scouting reputation and name. You have certainly asked a tough question -- but an answer is your right. Please know that I will be very honest with you in several points that you will need to understand clearly.


Registration (membership) at any level - but certainly at the adult level is a private role and responsibility of the Boy Scouts of America. We, like many organizations, have "rules" to our membership (i.e.; age, U.S. Citizen, Duty to God concept, etc.) that must be met. In this day and age of a "high awareness of child abuse", the Boy Scouts of America has increased its watchfulness of its adult membership. We simply cannot afford Scout leaders giving leadership to young men that have any type of record of present actions of child abuse -- of any type.

Since the above is true and since a record was filed with the Boy Scouts in 1968 and a letter of probational status membership was given to you in 1978 -- then you know that the Boy Scouts are within their rights as a private organization to restrict its membership to you.

However, your record from 1978 indicates no negative comments and you may, still at a probational status, remain registered in the Scouting movement. That is given as a privilege -- that I know you understand. So you may register at any level of unit Scouting -- as long as approval is given by the appropriate individual.

Again, Thank You for your letter and for your concerns -- hope this at least answers you some.



Racial Violence Flares In Cleveland As Well As On Mississippi March

CLEVELAND, Ohio (AP) — The summer calm in an East Side neighborhood was shattered by violence Thursday night as a young Negro boy was shot and wounded; a white woman was injured by a thrown brick, and shots were fired at two policemen.

Several businesses operated by white men were looted and vandalized.

It was the second night of trouble in the area but police said the situation was brought under control quickly.

The violence erupted along a section of Superior Avenue where Negro and white neighborhoods come together.

Earl Stapler, 39, a Negro, told a newsmen, "We want all the white businessmen out of this area, and you can quote me on that. If we can't go into Sowinski Park, then they can't come over here."

The Sowinski area has been a trouble spot before. Racial disturbances broke out there three years ago after a 15-year-old white girl was attacked by a group of Negro youths in the park.

The wounded boy, 3-year-old Stephen Griffin, was reported in fair condition at Mt. Sinai Hospital with a bullet wound in the lower abdomen. His brother, Richard, 16, said a white man fired the shot from a passing convertible.

There appeared to be no reason for the shooting, witnesses said.

Two patrolmen said they were fired on by two men across the street as they drove up in front of a grocery, where a smoke bomb had been thrown through the window. The men who fired

CANTON, Miss. (AP) — Frenzied by a hectic night of tear gas and tension, the Mississippi march regroups today for new "confrontations."

Dr. Martin Luther King Jr. said a detachment would drive 60 miles east to Philadelphia, Miss., a Ku Klux Klan stronghold, for a rally.

"We will maintain the peace come hell or high water," said Gov. Paul Johnson, in urging Philadelphia residents to stay away from the rally—part of the march's effort to spur Negro voter registration.

The busy schedule also called for organization of Negro boycott of downtown white merchants and a general work stoppage by Negroes in Canton, while a few continue the march toward Jackson.

From Canton, the march swings south along U.S. 51, the same highway where it all was started by James H. Meredith in Memphis, Tenn., 20 days and 220 miles ago. Jackson is 20 miles from Canton.

Meredith is the slender Negro who broke the racial barrier at the University of Mississippi in 1962. He was wounded by shotgun blasts June 6 as he walked near Hernando. Civil rights leaders rushed in to take up his march.

Recovered from his wounds, Meredith—now a Columbia University law student—planned to rejoin the march today.

Claude Sterrett, traveling with Meredith, said they would leave Memphis by car at 3 p.m. EST.

Meredith was carrying the ivory and ebony walking cane given him by an African chief-tain with tape binding the
